# **SUMMARY ANNUAL REPORT for the Contra Costa County Electrical Workers Retirement Plan**

This is a summary of the annual report for the Contra Costa County Electrical Workers Retirement Plan, employer identification number 94-6114525, for the period January 1, 2022 to December 31, 2022. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

## **BASIC FINANCIAL STATEMENT**

Benefits under the Plan are provided from trust funds. Plan expenses were \$24,631,003. These expenses included \$488,012 in administrative expenses and \$24,142,992 in benefits paid to participants and beneficiaries. A total of 1,454 people were participants in or beneficiaries of the Plan at the end of the Plan year, although not all of these participants had yet earned the right to receive benefits.

The value of the Plan assets, after subtracting liabilities of the Plan, was \$382,249,449 as of December 31, 2022, compared to \$451,823,815 as of December 31, 2021. During the Plan year the Plan experienced a decrease in its net assets of (\$69,574,367). The Plan had total income of (\$44,943,364), including employer contributions of \$17,195,399 and net gain from investments of (\$62,228,508) and interest on participant loans of \$89,730.

- 5) Loans and other obligations in default;
- 6) Leases in default of classified as uncollectible;
- 7) Transactions in excess of 5 percent of plan assets;
- 8) Information regarding any common or collective trusts, pooled separate accounts or 103-12 investment entities in which the plan participates.

The charge to cover copying costs will be \$4.50 for the full annual report, or 25 cents per page for any part thereof. You also have the right to receive from the Plan Administrator, on request and at no charge, a statement of assets and liabilities of the Plan and accompanying notes or a statement of income and expenses of the Plan and accompanying notes, or both. If you request a copy of the full annual report from the Plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for copying these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the CCEW Benefit Office, 1330 Arnold Drive, Suite 250, Martinez, CA 94553 and at the U.S. Department of Labor in Washington D.C. or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
