#### Worker's Compensation Pamphlet Update for Your New Hire Packet



Effective July 1, 2014, the Workers' Compensation pamphlet was updated with new pre-designation regulations to stay in compliance with California Law. These new regulations change the employee criteria when pre-designating a personal physician or medical group for work-related injuries or illnesses. The revised pamphlet includes two new forms: one for pre-designating a personal physician and one for pre-designating a chiropractor or acupuncturist.



California employers are required to give a Workers' Compensation pamphlet to all new employees at the time of hire, or no later than the end of the first pay period to stay in compliance with California Law.
