**2018 SUMMARY ANNUAL REPORT FOR THE ELECTRICAL WORKERS  
HEALTH & WELFARE PLAN FOR CONTRA COSTA COUNTY (IBEW 302)**

This is a summary of the annual report for the Electrical Workers Health and Welfare Plan for Contra Costa County, employer identification number 94-6085741, for the period January 1, 2018 to December 31, 2018. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**INSURANCE INFORMATION**

The Plan has contracts with Kaiser Foundation Health Plan, Inc., Anthem Blue Cross, Delta Dental Plan of California and HCC Life Insurance Company to pay certain hospital, surgical, medical and dental claims incurred under the terms of the Plan. The total premiums paid for the Plan year ended December 31, 2018 were \$14,027,476.

**BASIC FINANCIAL STATEMENT**

Benefits under the plan are provided through insurance and self-funded claims. The value of the Plan assets, after subtracting liabilities of the Plan, was \$15,817,789 as of December 31, 2018, compared to \$15,822,571 as of January 1, 2018. During the Plan year, the Plan experienced an increase in its net assets of (\$4,783).

During the Plan year, the Plan had total income of \$22,086,552, including employer contributions of \$21,401,418 retiree payments of \$994,326, net loss from investments of (\$377,380) and other income of \$64,996.

Plan expenses were \$22,091,335. These expenses included \$556,325 in administrative expenses, \$14,027,476 in premiums to insurance companies and \$7,507,534 self-funded claims. A total of 1,117 were participants in the plan at the end of the plan year.
