Joint Apprenticeship and Training Committee APPLICATION ANNOUNCEMENT

Our Inside Wireman's JATC will be taking applications during the month of January 2024 at IBEW Local Union 302, Martinez, on three Tuesdays (January 9^{th,} 16th, and the 23rd) from 1:00 p.m. to 3:00 p.m.

Applicants must be 18 years of age or older, be a high school graduate or equivalent, and must have a full year of high school algebra with a passing grade of C or better. Even at this late date, it is possible for a motivated individual to meet the math requirement by taking the self-paced algebra course offered by the Martinez Adult school, or taking the technical math class online at the Electrical Training Alliance Website.

We rely on our members to look for and encourage interested individuals to apply for our program as the future of this industry depends on our talent pool. Please distribute the announcement which can be downloaded <u>here</u> to any individual that you believe would be an asset to our industry.

NECA Contractor Call to Action - Act Now to Oppose SB 799 (Portantino)

We are urging all NECA contractors to use our grassroots advocacy page to send a preformulated email to Governor Newsom and Legislators asking that they oppose SB 799, which would provide striking workers access to unemployment Insurance (UI).

Background:

SB 799 was recently gutted and amended to allow unemployment benefits for striking workers. The measure would give striking workers the ability to claim unemployment after two weeks of striking.

Impact on the union construction Industry:

SB 799 fundamentally alters the nature of UI by providing unemployment to workers who still have a job and have chosen to temporarily refuse to work as a negotiating tactic. Striking is a federally protected right and has historically been a key strategy in labor disputes, but – to put it simply – being on strike is not the same as being laid off. In addition, if SB 799 is passed, when the unions choose to strike and receive UI they would also be impacting a signatory contractor's UI "experience rating" and driving up their UI taxes for years to come, making union contractors less competitive against their nonunion competitors.

Final Take:

By forcing employers to pay unemployment insurance payments to striking workers, this bill would raise costs on employers across the state and more specifically make union construction employers less competitive.

Suicide Prevention in the Construction Industry: Know the Signs and Help a Life

Wednesday, September 13th 2:00 PM ET

Studies show that suicide is killing workers in the construction industry at five times the rate of work-related injuries like falls and struck-by incidents. And it's killing them in all parts of the industry – including upper management. Unfortunately, there is no simple answer to why this is happening nor is there an easy fix, but in many cases deaths from suicide CAN be prevented when we push mental health stigma aside and help one another.

We will be joined on this webinar by a representative from NASCAR driver Daniel Dye's race team and the <u>Race to Stop Suicide</u> for a conversation about real issues affecting us every day and ways to spot signs of depression or feelings of hopelessness in colleagues, employees, and loved ones. In addition, our panelists will share their own experiences with mental health, engaging in suicide prevention activities in the workplace, and breaking down barriers in an industry that does not always welcome

conversations about feelings. Employers and other attendees will walk away with ideas to help reduce stigma and save lives and will learn more about mental health resources for the construction industry.

New Form I-9 Now Includes Alternative Procedure for E-Verify Employers to Remotely Examine Employee Documents

The new version of <u>Form I-9</u>, <u>Employment Eligibility Verification (PDF, 483.6 KB)</u> is now available for use. This version contains changes to the form and instructions, including shortening the Form I-9 to one page and reducing the instructions to eight pages. What Form I-9 versions may be used:

- Employers may begin using the new Form I-9 today, Aug. 1, 2023.
- The Form I-9 dated "10/19/2019" may continue to be used through Oct. 31, 2023. The version date can be found at the lower left corner of the form.
- Beginning Nov. 1, 2023, only the new Form I-9 dated "08/01/23" may be used.
- A revised Spanish Form I-9 dated "08/01/23" is available for use in Puerto Rico only.

A summary of changes (PDF, 185.1 KB) to the Form I-9 and instructions is available online.

Also beginning today, employers may remotely examine employees' Form I-9 documents provided they are enrolled in E-Verify. The alternative procedure is detailed in a <u>notice in the Federal Register</u> published on July 25, 2023.
