Position:

Apprentice Electrician (Inside Wireman) Starting Wage Approx: \$19.10/hr
This is a five-year apprenticeship program. Apprentices work during the day and attend classes two nights per week. A Journeyman certificate is awarded upon successful completion.

When:

Application dates for 2017 will be Monday, January 23, 2017 and Monday, January 30, 2017. Applications will be from 12:30 PM – 3:30 PM at IBEW Local Union 302, 1875 Arnold Drive, Martinez, CA 94553. Should there be any changes, information will be posted on our website. Call 925/228-2302 for questions. Applications must be completed on site and in person, no exceptions\*\*

Tests:

Applicants meeting the minimum requirements will be scheduled for the following steps. Notification will be verbal/or by mail. Eligibility will be determined by the Committee.

- 1. The NJATC Aptitude Test (including Algebra and Functions and a Reading Comprehension test) (see: <a href="https://www.electricaltrainingalliance.org">www.electricaltrainingalliance.org</a> website for more information)
- 2. Oral interview only if a qualifying score is achieved on the aptitude test.

#### **Duties:**

The Apprentice Electrician works directly under the supervision of and assists a qualified Journeyman Electrician in installing or maintaining a variety of approved wiring methods for distribution of electrical light, heat, power, radio and signaling utilization systems in existing or new buildings under construction of residential, commercial and industrial occupancies; including street and highway lighting, traffic signal and other outdoor above and below grade installations.

### Minimum Requirements: Each applicant must:

- 1. Be 18 years of age or older, with proof of identification, such as a drivers' license or identification card issued by the D.M.V. (Must have a valid drivers' license at time of indenture).
- 2. Be a High School graduate or equivalent.
- 3. Have completed one full year (2 semesters) of algebra in High School or one semester of algebra in College or Adult School with a passing grade of "C" or better.
- Applicants will be required to take and pass a pre-employment drug/alcohol test.
- 5. Women and minorities are encouraged to apply.

#### What to turn in on the date you make application:

- 1. Proof of identification.
- 2. An <u>official sealed</u> copy of your High School Transcripts <u>signed</u> by the Registrar's Office (No Diplomas) which we will check to verify that it includes your graduation date and proof of meeting the algebra requirement. If you did not graduate from High School, you will also need to provide an official GED Certificate as proof of High School Equivalency Graduation. If you did not take algebra in High School, you <u>must also provide</u> your College or Adult School Transcripts as proof of meeting the algebra requirement. The burden of proof is the applicant's responsibility. (NJATC online Tech Math Course will meet the algebra requirement) NO EXCEPTIONS.
- 3. All records must be presented in English.
