NECA APPOINTS NEXT CHIEF EXECUTIVE OFFICER

BETHESDA, Md.— The National Electrical Contractors Association (NECA) announced that T. David Long has been appointed as Chief Executive Officer (CEO). Long will officially join the NECA staff on April 1, 2019.

"After a national search, the Executive Committee unanimously selected David Long to serve as CEO," said Larry Beltramo, Chair of the NECA Search Committee and Vice President At Large. "David's experience as an electrical contractor, his current service as NECA President and his unending dedication to advancing our industry make him the ideal leader for NECA at this important moment in time."

With more than 40 years' experience in electrical contracting, Long currently serves as the President of Miller Electric in Jacksonville, Florida. He brings demonstrated experience in strategic planning and organizational growth, as well as leadership and mentorship of substantial teams. A dedicated NECA volunteer, David has held many roles within the association, including serving on the Board of Governors, Executive Committee and Council of Industrial Relations and most recently culminating as President of the Association.



Larry Beltramo Named Interim NECA President

With the selection of David Long as NECA CEO, the NECA Executive Committee has named Larry Beltramo, currently NECA Vice President at Large, as Interim NECA President until a new President is elected at the NECA Board of Governors meeting in September in Las Vegas. Long has notified the Executive Committee that he is resigning as NECA President on March 31, 2019 prior to joining the NECA staff on April 1. Beltramo will become President effective April 1.


According to the NECA Bylaws, when a vacancy occurs in the NECA President position the Executive Committee selects one of its members to become President and an election is held at

the next Board of Governors meeting following the vacancy to select a new full-term NECA President. The newly elected President will take office on January 1, 2020. At their June 2019 meeting the Executive Committee will nominate an individual for election as President.



Notice to Employers Signatory to the Sound & Communication Agreement


On November 30th of this year (2019), our Northern California Addendum to the Ninth District Sound and Communication Agreement with the IBEW will expire. The Chapters intend to negotiate a successor agreement that will be binding to all employers signed to a Letter of Assent. The process begins in late summer and should conclude by the end of November. The new agreement will become effective December 1, 2019.

As a practical matter, this is not an issue for most of our employers. However if you intend to terminate your relationship with the IBEW, you must do so in a timely manner by notifying the union of your intention. For employers signed to a Letter of Assent A, separate notifications must be sent to the Chapter and to the Local Union prior to the end of June. For employers signed to a Letter of Assent B, the notification to the Local Union must be sent prior to July 20, 2019. Since bargaining is a complicated legal process, an employer choosing to terminate should not do so without competent legal counsel.
