Labor Day, a holiday recognized under all of our Agreements with IBEW, will be observed on Monday, September 1, 2014. Our Inside Wireman Agreement and the Sound and Communication Agreement specifically prohibit any work from being performed on Labor Day, except in the case of an emergency.

You should also be aware that Friday, August 29, 2014, is a "Carpenters Off-Day" which is considered a holiday for the Inside Agreement—with the exception of Project Agreement Jobs and the Industrial Maintenance Agreement. The Friday before Labor Day is also a permanent holiday under the Sound & Communication Agreement.




