

It seems that the Edison Electric Illuminating Company could not keep up with the new demand, so "Mr. E" encouraged some of his foremen to act as contract installation companies.

Lastly, I came to a greater appreciation for what happened around here during the Second World War. One of the first Business Managers of Local 302, Red Lawrence, in "Local Union 302 IBEW" gives an account of a time the local had 11,500 members because of their marine unit that represented employees in the shipyards in Richmond. One of their biggest problems was to figure out how to get the \$25,000 to \$50,000 in dues they took in on a daily basis to the bank.

Like you, we look forward to bigger and better things over the next fifty years.




The old western span of the Bay Bridge between San Francisco and Treasure Island will show off 25,000 new LED lights into a light sculpture. The privately-funded 8 million dollar project is the largest sculpture of its kind in the world. Lights will flicker on and off and dim and brighten in waves and pulses on the 1.8 mile span for the next two years.

#### Material Handling, Site Logistics and Storage, and Crew Schedule

On Friday, March 22, 2013, the Electrical Industry Trust will host a half-day program that will address many of the issues and concepts necessary to successfully increase the productivity of on-site craft labor.
