2024 Inside Negotiations Concluded



On Friday, May 3, 2024, the bargaining parties representing the Chapter and Local 302 came to a settlement on this years Inside Negotiations.

The members of 302 approved the settlement at their meeting on Wednesday May 8, 2024.

There are no significant changes to the two-year agreement itself:

- ♦ Term: June 1, 2024 through May 31, 2026.
- March 1, 2025: \$4.50/hr to be allocated.
- ♦ March 1, 2026: \$4.50/hr to be allocated.

Independent of the negotiations, the parties also agreed to move twenty-five cents an hour of the Electrical Industry Trust Contribution from the Labor Management Cooperative Committee over to the Joint Apprenticeship and Training Trust to fund anticipated future expenses for training.

They also developed an Memorandum of Understanding for Residential Contractors regarding the use of CW/CE's on Residential Project Labor Agreement jobs in limited situations.

We will be printing up revised Agreement booklets for the members of both organizations and will distribute them among all the signatory contractors.

At this point we would like to thank the contractor representatives of our bargaining committee for their active participation in this thankless job: Casey Dias, Watson Electric; Charlie Hadsell, Contra Costa Electric; Rick Henry, Collins Electric; Barry McGraw, BME; Jordan Nunez, Dawson Electric; Jose Oseguera, Crockett Electric; and Jim Szuch, Elocin Construction.

ASKING the Right Questions Can Help Protect You from Sinister

Artificial Intelligence Voice-Cloning Scams

It's a nefarious con that uses AI to replicate the voices of your friends, family members, or colleagues. Be very wary when someone calls you up asking for money – even if it sounds like someone you know and trust. AI can now clone a voice after hearing it for just a few seconds. And cybersecurity experts have warned that criminals are using this to trick unsuspecting victims into handing over cash – by making "urgent" requests while posing as people you know.

If a loved one seems panicked on the phone, it can be tempting to help them no matter what, but it's important to ask the right question first. Being aware of the possibility is half the battle. Pay attention to what they are saying and try asking for details. If your child says they are with a friend, ask which friend. If a colleague talks about 'the big project,' get them to confirm the client, etc. Usually, these scammers will be calling from unknown numbers and claiming they lost their phone. So try calling the correct number or contacting them in a different way to confirm.

STAY CALM. Any time someone calls you with an urgent request, it can be worrying. This is especially true if a loved one is claiming to be in a crisis – or your boss is ringing you with a serious demand. But the important thing is to not rush into any decision. Take the time to verify any requests for money, even if they seem to be coming from someone who you trust. The first and most important thing to do is not to panic.

Cyber criminals are very good at getting victims to act quickly and often use situations where there is an imminent risk of harm. Try and verify the identity of the person calling you by asking lots of very specific questions that only the real person would know. Make sure the answers to the questions are not known publically, as scammers may potentially have certain information, which had been collected from sources like social media accounts.

There is also a way of setting yourself up to be protected from this type of scam ahead of time. It is worth sitting down with your closest friends, family members, and important colleagues to arrange a "safe word." If the person on the other end of the line doesn't respond with the correct answer, the chances are you are speaking to an Al fake.
