IBEW 302 Wage Allocation

Effective September 3, 2018

We have attached the <u>new wage rates</u>, <u>cost per hour sheets</u>, and <u>shift rates</u> for IBEW Local 302 Inside Wireman which become effective on September 3, 2018. The rates include a \$2.00 increase to the Journeyman wage rate on that date.

The rates also reflect a significant change to our variable pension/wage arrangement for the past 30 years. During bargaining in 2018, the employers granted latitude to the IBEW on the wage/pension arrangement. The members of IBEW 302 voted to change to one pension rate of \$10 per hour for all journeymen, foremen, general foremen, senior general foremen, cable splicers and welders. Apprentices in years 2-5 of the program will remain at \$2.00 pension, and first year apprentices do not receive pension contributions, the same as in the past. Prior to this change, the bargaining parties also agreed to remove the provision that a "man-in-the-area" for a traveling employer be paid differently (at Class III). As a result, all employees will now be treated the same, regardless of how they were dispatched.

Depending on how "dialed-in" certain individuals are to what goes on within IBEW Local 302, there is a chance that some individuals currently in Class II, III, IV, and V will not be aware of the forthcoming changes, which will result in less take-home pay but more Retirement Trust contributions. You may want to review your employee list and advise individuals that will be affected by these changes prior to the payroll check that first reflects the modification, as some may wish to change their withholding.

The changes noted above should simplify the payroll and fringe benefit reporting process significantly.

Odd's and End's from 2018 Inside Negotiations

The printed booklet version of the <u>Inside Wireman Agreement</u> should be mailed to all contractors by the end of September. While most of the items agreed to are found in the new booklets, we wanted to make you aware of some changes that do not appear in the actual text of our Inside Agreement with Local 302 for a variety of reasons.

Pre-Employment "Quick Test"

The Occupational Safety Councils of America (OSCA) offers the agreed upon Quick Test at its facility in Martinez. Their address is 1805 Arnold Drive in Martinez – just a few doors down from IBEW Local 302.

Any employer requiring the "quick test" should notify the dispatch office that it is a condition of employment for applicant. It is up to each employer to set up a billing account with OSCA (925-335-5000) to pay for this. As with any method of testing employees for drug and alcohol issues, make sure that confidentiality protocols are in place prior to implementation.

♦ 9/80 Work Schedule

There are a few facilities where our employers are asked to work their employees on the same schedule as "in-plant" employees operating on a <u>9/80 schedule</u>. Under that arrangement, employees work 9 hours per day/Monday through Thursday in one week and 9 hours per day Monday through Thursday and 8 hours on Friday the second week. They work a total of 80 hours in a 2-week period, 36 in week 1 and 44 in week 2. The key to this arrangement is that the payroll period for those employees must begin at 11:31 a.m. on Friday and end at 11:30 a.m. on the following Friday. Please note this option is not available for most employers and can only be used with mutual consent of both parties. We do not anticipate its use outside of the facilities where it has historically been used.

Market Advancement Initiative

The scope of the Market Advancement Initiative, which we usually refer to as "the CW/CE Agreement," has been modified to include most private work, the same as in the NECA/IBEW areas surrounding us. It will now include most tenant improvement work and office space. The exclusions are work under Project Labor Agreements, Public Works, work in the refineries (which are now under a PLA) and specific customer's work presently/historically performed by signatory employers.
